4. Field of Specialization: Polymer chemistry (including fields related to organic materials and composites)
5. Position Responsibilities: Lectures, seminars, and experiment courses related to polymer chemistry, polymer properties, and organic chemistry in undergraduate and graduate schools; courses related to the above fields of specialization in graduate school; and liberal arts education subjects
6. Application Deadline: Must be received no later than August 18, 2025

 - (1) Individuals with a Doctoral Degree or a Ph.D. (including those expecting to obtain it by the time of employment)
 - (2) Individuals with excellent research achievements in the field of polymer chemistry and who are highly motivated in education and research
 - (3) Individuals with a track record of obtaining external funding and who can continue to obtain future research funding
(However, for applicants affiliated with private companies, a track record of obtaining
