奨学金

既に奨学金を受給している留学生の手続き

○文部科学省奨学金(MEXT 奨学金)

毎月指定の期間内に国際教育課でサインをして下さい。その月の奨学金は20日頃に振り込まれます。

その月の末日までにサインができない場合は、その月の奨学金はもらえません。

旅行・一時帰国などで本学を離れる場合、不在日数により奨学金を支給できない事があります。必ず事前に国際教育課担 当者に相談してください。

日本での勉強が終わって国へ帰るときに、帰国旅費として新東京国際空港(成田空港)または熊本から一番近い国際空港からあなたの国の国際空港までのエコノミークラスのチケットがもらえます。(もらえない条件の学生もいますのでご注意ください。)毎年 6 月、12 月頃に国際教育課から対象者へ案内をします。手続きは熊本大学ではなく、文部科学省がまとめて全国の大学の手続きを行うので、申請後に旅程の変更を行うことは非常に困難です。なお、チケットをお金に替えることはできません。

○JASSO 協定受入奨学生

毎月指定の期間内に国際教育課でサインをして下さい。その月の奨学金は20日頃に振り込まれます。

旅行・一時帰国などで本学を離れる場合、不在日数により奨学金を支給できない事があります。<u>必ず事前に国際教育課担当者に相談してください。</u>

※留学期間が終了する前に、必ず「修了報告書」及び本学で取得した成績を国際教育課に提出してください。

その他たくさんの奨学金があり、その年度で募集要項や募集時期などに変更になることがあるため、必ず各部局の掲示板及び Moodle の留学生支援ページで確認してください。 申込窓口は、奨学金によって異なりますので、募集要項にて必ず確認してください。※下記ウェブサイトには主な奨学金名がリストアップされています。ご覧ください。

注意点: 卒業が近づくと、就職等でビザの変更を希望される方がいますが、留学ビザからその他のビザに切り替わってしまうと、 変学金受給期間であっても受給できなくなる可能性がありますので、ビザの変更に関しては必ず国際教育課へ事前にご相談ください!!

Scholarship

Procedures for Scholarship Recipients

Japanese Government (Monbukagakusho) Scholarship Students (MEXT Scholarship)

Students are required to sign for their monthly stipend at the International Student Office within the designated period of each month. The scholarship for that month will be paid around 20th of each month.

If you cannot sign by the end of the month, your stipend for that month will not be provided.

If you leave for travel or temporary return to your country, you may not be able to receive the scholarship depending on the number of days you are away. Please be sure to consult with the International Student Office in advance.

When you return home after completing your studies in Japan, you will receive an economy-class plane ticket between the New Tokyo International Airport (Narita) or the international airport nearest to Kumamoto and an international airport in your country. (Please note some students are not eligible.) International Student Office will inform the eligible students about the application for the return flight ticket around in June and December. The MEXT will conduct the procedures for all the scholarship students in Japan, so it is very difficult to change the itinerary after submission of the application. It is not transferable into money.

O Short-Term Exchange Program Students Scholarship Sponsored by JASSO (Japan Student Services Organization)

Students are required to sign for their monthly stipend at the International Student Office within the designated period of each month. The scholarship for that month will be paid around 20th of each month.

If you leave for travel or temporary return to your home country, you may not be able to receive a scholarship depending on the number of days you are away. Please be sure to consult with the International Student Office in advance.

**After your scholarship term ends, it is required to submit "Study Completion Report" and your transcript which you obtained at Kumamoto University to the International Students Office when it becomes available.

Procedures for those wish to apply

Various scholarships are available, and the application guideline and period are subject to change each year. Therefore, be sure to check the bulletin boards of Students Affairs Office of your faculty and "Support for International Students" (KU Moodle page)

X The main scholarship names are listed on the website below. Please check the list.

Note: Some students wish to change their visa status for employment, etc. as their graduation comes close. If their visa has changed from "student" to another, they <u>may not be able to receive the scholarship even during their scholarship period</u>. Please be sure to consult with the International Student Office in advance for visa change!

- 経済的理由により入学料の納入が著しく困難であり、かつ学業優秀と認められる者
- 入学前1年以内において、入学する者の学資負担者が死亡し、又は入学する者若しくは学資負担者が風水害等の 災害を受けたことにより、入学料の納入が著しく困難であると認められる者 ※風水害等の適用範囲は日本国内の みとなります

徴収猶予対象者

- 経済的理由により納入期限までに入学料の納入が著しく困難であり、かつ学業優秀と認められる者
- 入学前1年以内において、入学する者の学資負担者が死亡し、又は入学する者若しくは学資負担者が風水害等の 災害を受けたことにより、入学料の納入が著しく困難であると認められる者 ※風水害等の適用範囲は日本国内の みとなります

- ・病気、留学等の特別な理由がなく、留年している者
- ・病気・留学等の特別の理由がなく、最短修業年限を超えている者
- ・申請に係る学期の開始6ヶ月以内に懲戒処分を受けた者及び処分中の者

3. Scholarships/Student Fee Exemption

Entrance Fee · Postponement / Tuition Fee Exemption

This is a system that exempts or postpones the payment of all or half of the entrance fee and exempts the payment of all or half of the tuition fees for the following qualified applicants, upon selection based on the application from the student.

Entrance Fee Exemption / Postponement *Non-degree Research Students and Credited Auditors are not eligible to apply. Entrance Fee Exemption (Eligibility)

Students with excellent academic records who find it extremely difficult to pay the entrance fee due to economic reasons.
Students who find it extremely difficult to pay the entrance fee because the individual is chiefly responsible for their academic expenses ("Academic Expense Supporter") has passed away, or the students themselves or their Academic Expenses Supporter have suffered major damage from wind, flood, or other disasters within twelve months prior to matriculation. *The scope of application for wind and flood damage is limited to Japan.

Entrance Fee Postponement (Eligibility)

- Students with excellent academic records who find it extremely difficult to pay the entrance fee by the deadline due to economic reasons.
- O Students who find it extremely difficult to pay the entrance fee because their Academic Expense Supporter has passed away, or the students themselves or their Academic Expenses Supporter have suffered major damage from wind, flood, or other disasters within twelve months prior to matriculation. * The scope of application for wind and flood damage is limited to Japan.

Tuition exemption *Non-degree Research Students and Credited Auditors not able to apply.

Eligibility

- Students with excellent academic records who find it extremely difficult to pay the tuition fee due to economic reasons.
- O Students who find it extremely difficult to pay the tuition fee because the Academic Expense Supporter has passed away, or the students themselves or their Academic Expenses Supporter have suffered major damage from wind, flood, or other disasters within six months prior to the payment due date (if newer student, within 12 months). * The scope of application for wind and flood damage is limited to Japan.

**For privately financed international students, the students themselves (or spouse) are considered as Academic Expense Supporter. **Even if you are corresponded to the above, it will not be eligible if you are any the followings.

- · Students who have already paid tuition fee for the semester to be applied.
- · Students who have been repeating the same academic year without special reasons such as illness or studying abroad.
- · Students who have exceeded the minimum years required for graduation without special reasons such as illness or studying abroad.
- · Students who have received disciplinary action within six months prior to the start of the semester or at the time of the application are ineligible for tuition exemption.
